- Timing: You averaged 1:13 minutes per question, which is faster than the target pace of 1:42 minutes.

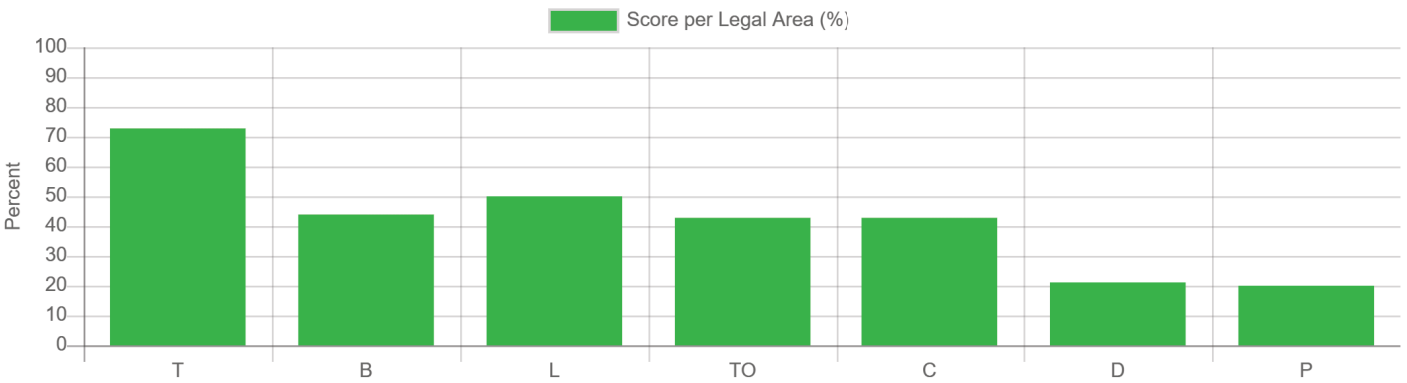

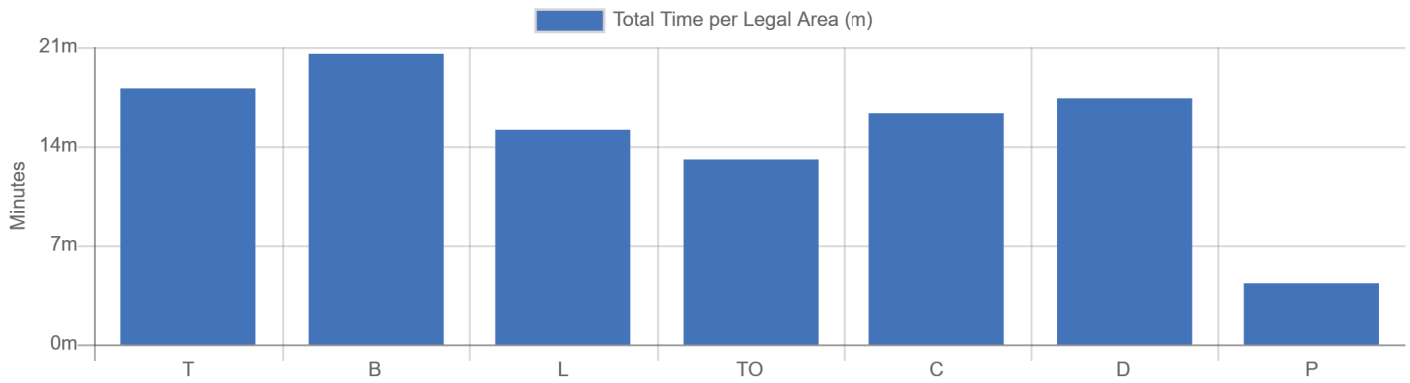

- ● Good Pace (\leq 1:42 mins): Efficient, well-balanced answering speed.

5. Recommended Next Steps

- Reinforce weak subjects: Prioritise Professional Conduct and Dispute Resolution, which had the lowest scores and slowest pace.
- Develop timing discipline: Set yourself a strict target of 1 minute 42 seconds per question, which is the recommended pace, and move on if uncertain, returning later if time permits.
- Timed-mock tests practice: Continue with timed mocks under exam conditions to replicate real SQE1 pressure.

✔ Overall Recommendation: Focus on improving your accuracy in the weaker areas while maintaining your good pace. Allocate more revision time to Business Law and Practice, Tort, Contract, Dispute Resolution, and Professional Conduct. Use practice questions to test your understanding and identify specific areas for improvement.
